Name	Description

Inspection Summary	View inspection results for three accreditation cycles as either percent of inspection requirements, compliant, or deficient.	
Inspection Summary by Section/Department	View a single laboratory's inspection results for three accreditation cycles.	
Inspection Summary by Checklist Module	View inspection results by checklist module discipline for three accreditation cycles as a percent of inspection requirements compliant or percent deficient.	
Inspection Detail by Checklist Module	View your laboratory's inspection results by checklist module for three accreditation cycles for each checklist module. Use this report to identify the disciplines within your laboratory with inspection deficiencies. This report may also be used to determine the number of checklist requirements used on each inspection for each laboratory.	
Inspection Summary by Phase	View your inspection results for three accreditation cycles by requirement Phase 1 or 2 as percent deficient or compliant. Phase 1 deficiencies compromise the quality of the services without endangering the health and safety of patients, clients, or personnel. Phase 2 deficiencies may have a serious impact on the quality of services or may endanger the health and safety of patients, clients, or personnel.

Name	Description	
Analyte Scorecard	View PT scores for each analyte and associated subspecialty performed by your laboratory (or system of laboratories) for up to three years.	
Laboratory System	View PT performance averages for your entire laboratory system on a year and event basis. Averages can be compared to the overall CAP benchmark, as well as the respective demographic group average for each laboratory.	
Laboratory System Subspecialty and Analyte Summary	View PT performance averages for each subspecialty and analyte in your laboratory on a year and event basis. Averages can be compared to both your demographic group average and overall CAP benchmark.	
Analyte Performance Comparison Across Labs	Compare analyte performance across laboratories in your system on a year and event basis. Averages can be compared to the overall CAP benchmark, as well as the respective demographic group average for each laboratory.	
Subspecialty Performance Comparison Across Labs	Compare subspecialty performance across laboratories in your system on a year and event basis. Averages can be compared to the overall CAP benchmark, as well as the respective demographic group average for each laboratory.

Inspection Summary by Section/Department	View a single laboratory's inspection results for three accreditation cycles.	
Inspection Summary by Checklist Module	View your system's inspection results by checklist module for three accreditation cycles as a percent of inspection requirements compliant or percent deficient. Use this report to identify disciplines within your system with inspection deficiencies.	
Inspection Detail by Checklist Module	View your system's inspection results by checklist module for three accreditation cycles for each checklist module. Use this report to identify the disciplines within your system with inspection deficiencies.	
Inspection Summary by Phase	View your inspection results for three accreditation cycles by requirement Phase 1 or 2 as percent deficient or compliant. Phase 1 deficiencies are those that compromise the quality of the services without endangering the health and safety of patients, clients, or personnel. Phase 2 deficiencies are those that may have a serious impact on the quality of services or may endanger the health and safety of patients, clients, or personnel.	
Deficiency Frequency Summary	View the frequency at which each deficient requirement was cited in your system laboratories. Use this report to identify the most frequently cited requirements. You can use this information to identify potential deficiencies in laboratories that are due for inspection soon. You can also share the information with the laboratories in your system to use during self-inspections.

Accreditation Reports	
Name	Description
Laboratory Deficiency Distribution Summary	View deficiencies by section/department and by cycle for your system laboratories. Use this report to identify whether inspection deficiencies are spread across the laboratory or concentrated in one or more sections/departments.
Requirement Deficiency Detail	View details for a specific requirement that has been cited in one or more of your laboratories within your system. Use this report to examine frequently cited deficiencies and identify system-wide issues. Use this information to mitigate the risk that other laboratories are also out of compliance with a requirement.
Laboratory Deficiency Detail	View your laboratory's deficiencies for the last three accreditation cycles, one cycle at a time. Use this report to examine each laboratory's inspection results as well as the responses to the deficiencies that were cited.
Inspection Result Summary	View summary information for your system laboratories that were inspected within a selected period.
Accreditation Decisions	View summary information for your system laboratories that were accredited within a selected time period.
